

Resolution No. 47/02/2025
of the Senate of the University of Rzeszów
dated February 24, 2025
on the principles of organization and operation
of the Internal Quality Assurance System
at the Doctoral School of the University of Rzeszów

Pursuant to § 35(1)(9) of the Statute of the University of Rzeszów (Resolution No. 34/12/2024 of the Senate of the University of Rzeszów, dated December 16, 2024, on the adoption of the Statute of the University of Rzeszów), the Senate of the University of Rzeszów hereby resolves as follows:

**§**1

- 1. In order to foster a conscious culture of quality education, developed by all members of the academic community, and in accordance with the mission of the University of Rzeszów, the Internal Quality Assurance System for Education at the Doctoral School of the University of Rzeszów, hereinafter referred to as IQAED, is introduced.
- 2. The IQAED is created with respect for the autonomy and specific nature of the organizational units responsible for education.

§ 2

The specific objectives of the IQAED include all activities aimed at improving the quality of education, relating to the entire educational process, and in particular:

- 1) the assessment of the adequacy of the education program and individual research plans to the learning outcomes for qualifications at level 8 of the Polish Qualifications Framework, as well as the assessment of their implementation,
- 2) the improvement of the method for verifying learning outcomes for qualifications at level 8 of the Polish Qualifications Framework,
- 3) monitoring the qualifications of academic teachers or research staff involved in education at the Doctoral School of the University of Rzeszów,
- 4) the improvement of the enrolment procedure,
- 5) the improvement of the quality of scientific or artistic supervision and of support in conducting scientific or artistic activities,
- 6) the assessment of the reliability of the mid-term evaluation process,
- 7) the improvement of the process of internationalization of education at the Doctoral School of the University of Rzeszów,
- 8) the assessment of the effectiveness of doctoral students' education.



The objectives of the IQAED are achieved primarily through the periodic conduct of surveys at the University of Rzeszów, the collection and analysis of the results of these surveys, and the undertaking of evaluative actions, as well as other activities, including the development of procedures and legal acts.

**§**4

- 1. The IQAED is implemented on an ongoing basis by the UR Doctoral School Council.
- 2. In justified cases, in order to effectively implement the tasks of the IQAED at the University level, the Rector may appoint ad hoc committees, specifying their composition, scope of activities, and duration of operation.
- 3. In order to effectively implement the tasks of the IQAED at the organizational unit level, the Head of the Doctoral School of the University of Rzeszów is authorized to appoint ad hoc committees, specifying their composition, scope of activities, and duration of operation.

§ 5

- 1. The Rector is responsible for the supervision of the functioning of the IQAED at the University. The following are within his exclusive competences:
  - 1) making decisions concerning the functioning and objectives of the IQAED,
  - 2) issuing orders and other legal acts necessary for the efficient and effective functioning of the system.
- 2. The Head of the Doctoral School at the University of Rzeszów is responsible for the implementation, improvement, and coordination of activities within the IQAED.

§ 6

The competences of the bodies responsible for the creation of the IQAED, their specific tasks, as well as the method for conducting surveys and analyzing their results, are defined by separate orders of the Rector.

**§**7

In matters not regulated by this resolution, decisions will be made by the Rector.

- 1. The resolution shall be effective from the date of its adoption by the Senate of the University of Rzeszów.
- 2. Resolution No. 508/11/2019 of the Senate of the University of Rzeszów, dated November 28, 2019, regarding the functioning of the Internal Quality Assurance System for Education at the University of Rzeszów, as amended, is hereby repealed.
