	COURSE SUMMARY		

(Synthetic description of the course content and objectives; 100-200 words)

The seminar classes are designed to deepen general linguistic knowledge and specific knowledge of the doctoral field, namely linguistic geneology, press text geneology and text linguistics. In the fourth year of study, special emphasis is placed on scientific discussion and presentation of various research positions.

An important part of the classes is the development of the ability to look critically at the literature on the subject and to use it selectively in one's own work, in the final year of training the focus will be on methodological problems focused on analysis.

The class will primarily serve to discuss the preparation of the following chapters of the dissertation, both the theoretical chapters and analytical material and its use in the dissertation will be discussed in the class.

Attention will also be given to the preparation by the doctoral student of a review intended for the German journal Beiträge zur Fremsprachenvermittlung, for scientific meetings at the Department of Applied Linguistics and other scientific meetings or conferences, or discussion regarding participation in dissertation defenses. When it is possible for a doctoral student to participate in a conference (in accordance with the research topic), she plans to prepare a speech to be discussed in class.

In the context of the progress of the dissertation preparation, it should be added that due to the pandemic, it was not possible for the doctoral student to travel to Germany for a library search, which delays the preparation of the dissertation.
