BRIEF DESCRIPTION OF COURSE

(100-200 words)

The seminar is a basic 'subject' (inverted commas, as it is not a subject in school terminology) in doctoral students' education. Its implementation consists in the systematic activity of the supervisor leading to the writing of the dissertation by the doctoral student. It is very important to build appropriate relations

and continuous discussion, resulting from the progress of research and involving a systematic expansion of the subject, sometimes even difficult to predict and plan already in the first semester.

The so-called 'programme content' is basically a formal and methodical canon, inherent in the supervisor's care with only a few substantive issues. In this particular case, it concerns the inventorying of monuments, their protection and care in accordance with the norms of Polish and European legislation.

METHODS OF INSTRUCTION

At the level of doctoral preparation, the only legitimate didactic method is a conversation (discussion) with the doctoral student. It takes place in two stages - an introductory talk on parts of the dissertation and - a discussion of the already written chapters (subchapters) of the dissertation.

- 5. final conclusions recommendations for state and local administration, with particular emphasis on conservation services.
