#### **ABSTRACT OF THE SUBJECT**

In the Doctoral Studio, the doctoral student develops and deepens his/her skills of conducting artistic research in the field of graphic art. The subject is intended to provide substantive support for ongoing activities related to the research work. It clarifies and supplements the material in the doctoral student's area of research. It suggests specialised literature and other materials helpful in deepening the awareness of the artistic value of the work and the self-assessment of one's own activities. It helps to discover the doctoral student's individual artistic expression and exercises the ability to verbalise one's own reflections and artistic goals. An important aim is also to reflect on the language of writing about art in the context of one's own work, and in the perspective of preparing a description of one's doctoral thesis.

Discussion and continuous analysis of primary and secondary literature. Construction of a cycle, a set as a proposal or declaration. Workshop, technological correction. Monitoring and stimulating artistic achievements including exhibitions and others during the reporting period. Supervision of the realisation from the workshop and theoretical side. Working on the text of the self-reference in the context of the progress of the artistic and research task and the correlation of the two. The issue of progress and completion of the work in the different stages.
