

**Information clause for persons employed or admitted to tasks related to activities subject to protection within the meaning of the Act of 13 May 2016 on Counteracting Sexual Crime Threats and the Protection of Minors.**

Pursuant to Article 13 of the Regulation (EU) 2016/679 of the European Parliament and of the Council as of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (Official Journal of the European Union, L Series, 2016, Volume 119, Page 1.) (hereinafter referred to as "GDPR"), the University of Rzeszów (UR) informs that:

3. UR may process your data for the following purposes:
  1. Verification in the Register of Sexual Offenders – pursuant to Article 6(1)(c) of the GDPR in conjunction with Article 12(6) and (7) of the Act of 13 May 2016 on Counteracting Sexual Crime Threats and the Protection of Minors (consolidated text: Journal of Laws of 2024, item 1802, as amended) and § 14 of the Regulation of the Minister of Justice of 31 July 2017 on the procedure, manner, and scope of obtaining and providing information from the Register with limited access and the method of creating a user account (Journal of Laws of 2017, item 1561, as amended);
  2. Receiving and storing information from the National Criminal Register and other documents resulting from Article 21 of the Act of 13 May 2016 on Counteracting Sexual Crime Threats and the Protection of Minors – consolidated text: Journal of Laws of 2024, item 1802, as amended) – pursuant to Article 6(1)(c) of the GDPR;
  3. Fulfilling legal obligations regarding documentation storage – pursuant to Article 6(1)(c) of the GDPR in conjunction with the Act of 14 July 1983 on National Archival Resources and Archives.
4. Your personal data may be shared with entities authorized to receive them under generally applicable law.
5. Your personal data will not be transferred outside the European Economic Area or to international organizations.
6. Your personal data will be stored for the period required by relevant legal provisions.
7. You have the right to: obtain information on the processing of personal data and rights under the GDPR, access the content of your data and rectify them, as well as the right to delete personal data from the controller's records (unless further processing is necessary for the performance of a legal obligation or for the establishment, exercise, or defense of claims), and the right to restrict processing, data portability, and the right to object to processing – in cases and under conditions specified in the GDPR.
8. The provision of personal data specified in point 3, sub-points 1) and 2), is a statutory requirement and you are obliged to provide them. These data are necessary to carry out the verification process. In case of refusal to provide data, you will not be admitted to tasks related to activities covered by the protection of minors.
9. You have the right to lodge a complaint with a supervisory authority. In Poland, the supervisory authority is the President of the Personal Data Protection Office (ul. Stawki 2, 00-193 Warsaw, [www.uodo.gov.pl](http://www.uodo.gov.pl)).
10. You will not be subject to decisions made in an automated manner (without human intervention). Your personal data will also not be used for profiling.
